

# **Dress Code Policy**

# **PURPOSE**

The purpose of the Student Dress Code is to outline Lake Bolac College's requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes. This dress code has been developed by Lake Bolac College's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- foster a sense of community and belonging and encourages students to develop pride in their appearance
- support Lake Bolac College's commitment to ensuring that our students feel equal and are dressed safely and appropriately for school activities.
- reduce student competition on the basis of clothing
- enhance the profile and identity of the school and its students within the wider community.

The School Council has developed a dress code that we believe provides a range of choices for students and is cost effective for families.

### **SCOPE**

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

# **UNIFORM AND APPEARANCE**

Lake Bolac College's compulsory school uniform items are as follows:

### SCHOOL UNIFORM

- White, blue and maroon checked school dress
- Navy pinafore
- School kilt
- Navy or grey shorts
- Navy or grey pants
- Navy polo top with school logo
- Navy polo fleece vest with school logo
- Navy polo fleece jumper with school logo
- Navy woolen jumper with school logo
- Navy jacket with school logo (embroidered for Year 11-12 students)
- Rugby jumper Year 6 and Year 12 Class of Current Year (only to be worn in that given year)
- White or black socks, no logos, writing or other colours.
- Navy tights (not activewear or leggings)
- Black school shoes









### SPORTS UNIFORM

### General sport:

- Navy and sky blue polo shirt with school logo
- Navy shorts, skort, tracksuit pants or leggings (without large logos or alternate colours)
- Sports shoes (runners, joggers)

#### Swimming:

- One-piece bathers or swim shorts and a rash top
- Suitable footwear (thongs/sandals/crocs), to be worn to and from pool
- When representing the College a designated swimming cap is worn

### **HATS**

Years P-4: Navy wide brimmed with school logo Years 5-12: Navy cap or wide brimmed with school logo

#### General appearance

While at school, travelling to or from school or participating in school activities, Lake Bolac College students must comply with the following:

- Uniforms must be clean and in good repair
- Uniforms must be clearly marked with the owner's name
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these
  undergarments match the colour of the school uniform, with no visible logo or adornments.

### Jewellery and cosmetics

Students are not permitted to wear decorative jewellery to school. Plain stud earrings and sleepers (maximum 6mm) worn in the ears, and watches, are the only acceptable jewellery.

Cosmetics and nail polish may be worn, provided it is natural in appearance.

### **Hair and Sun safety**

Shoulder length or longer hair is to be tied back to help restrict the spread of nits and lice and for student safety. Hair accessories should be in school colours and minimalistic.

School uniform hats must be worn outside during Term 1 and Term 4 and on any other day prescribed by the school. School uniform hats may also be worn outside of this time period, by parent or student choice.

Hats and beanies are not to be worn inside.

Students are permitted to wear sunglasses during outdoor activities.

#### **IMPLEMENTATION**

Lake Bolac College will ensure that this Student Dress Code is communicated to all families and students through Compass. We will assist students who may be experiencing difficulties complying with this policy where possible.

Lake Bolac College students wearing non-compliant uniform items may be asked to change into a compliant item of clothing provided by the school.

If a student is out of school uniform or otherwise breaches the Student Dress Code on a recurring basis, a note will be provided to the student and parents by the classroom teacher. If non-compliance with the dress code becomes a continued occurrence, the Principal or a member of the leadership team will be informed and a phone call home may be required. In this event, the school will continue to work with the student and family to support compliance.

Measures taken by Lake Bolac College to address concerns about student non-compliance with the Student Dress Code will also be addressed in accordance with our Student Wellbeing and Engagement Policy.

# **EXEMPTIONS TO STUDENT DRESS CODE**

We recognise that there may be situations where the application of this dress code may affect students unequally. Students and their parents or carers may apply in writing to the Principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic or cultural beliefs or background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or their parents/carers can demonstrate particular economic hardship that prevents them from complying with the dress code.

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carers
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will then try to negotiate a resolution that is acceptable to all parties. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.
